CONSTANTIA NORTH SHORE SEWER PROJECT

A. Constantia Sewer Project Progress:

- ✓ Funding agencies have indicated that SOCRIS must have funding and be underway before Constantia's project will be eligible for funding.
- ✓ Project Score on the NYSEFC 2026 Intended Use Plan (IUP) – 126 points.
- ✓ Income Surveys Complete. District MHI reported as \$60,000.
- ✓ EFC PLUS Listing Update submitted on 5/29.
- ✓ \$1.75M STAG Grant – Procurement Flexibility Request approved 7/1/2026
 - **Nancy is setting up grants.gov to prepare grant agreement application**
- ✓ **Sanitary Survey complete!**
- ✓ **WQIP Application submitted for \$10M!**
- ✓ **Enhanced WIIA Application submitted for \$25M!**

Upcoming items:

- **Assist Town in completing STAG grant agreement application on grants.gov**

B. SOCRIS Progress:

- ✓ IMA approved with Constantia and most recently Hastings
- ✓ County developing Treatment Agreement with the City of Fulton.
- ✓ Meetings with ESD, Governor's office, Senator Ryan, Assemblyman Barclay, DEC and EFC. SOCRIS creates a significant opportunity for Economic Development in the region.
- ✓ Oswego County Water Agency has been formed and holds monthly meetings.
- ✓ SOCRIS Bond Resolution authorized by the County Legislature
- ✓ Oswego County Sewer District No. 1 Sewer District in the process of being formed.
- ✓ \$12M included in the FY26-27 NYS budget resolution for SOCRIS project!
- ✓ SOCRIS design underway! This shows progress and will help support Constantia funding applications!
- ✓ **Several funding applications submitted including WQIP, IMG, ESD!**
- ✓ **Oswego County met with City of Fulton to develop IMA which is needed to form County SOCRIS sewer district.**

C. Constantia Sewer Project Target Funding Opportunities:

- NYSEFC Enhanced WIIA:
 - Project is eligible for up to 25% of net project costs up to \$25M
 - **Applications submitted on July 31 for \$25M!**
 - NYSEFC Base Additional Subsidy:
 - Eligible communities can receive up to 25% of net project costs up to an additional \$2M
 - NYSDEC WQIP Grant:
 - Project is eligible for grant up to \$10M
 - **Applications submitted on July 31 for full \$10M!**
 - Other Grant Opportunities:
 - USDA RD Grant
 - NBRC Grant
 - ESD Grant
 - CDBG Grant
 - STAG/CPF Grant
 - Micron
